Special English as Second Language

Course Duration:

120 hours

Medium of Instruction:

English

Course Objectives:

To provide participants with further assistance in developing their ability:-

- a) To understand and interpret authentic oral text in the lecture and discussion context;
- b) To understand and interpret written text on Education;
- c) To express ideas and opinion in English on matters relating to Education simply and directly in speech as well as in writing in generally well-formed utterances;
- d) To read passage aloud with acceptable pronunciation, rhythm intonation and stress, and
- e) To express themselves in general communicative and functional English.

Course Content:

- Listening skills. Practice in comprehending dialogues, lectures and discussions in the language laboratory, live situations and in the lecture room.
- Reading skills. Practice in intensive reading of abstracts from various texts on Education used in the course.

 Assistance will be given to participants in understanding difficult passages in their textbooks on Education.
- Speaking and Writing Skills. Practice in class in expressing ideas and opinions on matters relating to Education. Particular attention will be paid to their errors in grammar, lexis and pronunciation.
- 4 Reading Aloud. Participants will be given further speech training involving the use of phonetics. They will receive practice in pronunciation, syllabic stress, phrasing, rhythm, intonation, etc.

General Communicative Skills. Practice in the use of language in common situations. These sessions will be activity-orientated (eg. describing events/persons, things, giving instructions, asking for information, and expressing opinions on topics of current interest).
